LCH Lead Program Terms and Conditions

Approved Lead Program Contractor agrees that if they receive leads from this program, that they will perform the client work to the best of their ability and will only hire additional subcontractors when absolutely necessary that are duly licensed and insured per LCH and State of California requirements. The League of CA Homeowners has the right to terminate this agreement if Approved Contractor does not show an effort to represent themselves in a legal and appropriate manner or for any other reason at the discretion of the President. All terms and conditions are subject to change at any time by LCH. Approved contractor agrees that company must remain in good standing and in full Approved status with LCH to be a participant in this program. A lead is defined as any LCH-reviewed homeowner information that has passed from LCH to the contractor via any mode of media selected by participant above. LCH is not responsible for leads sent via the method selected but not received by contractor. Cancellation of Lead Program participation by a contractor must be in writing and faxed or mailed to the LCH offices.

Payment for leads will not terminate until the Friday following termination notice being received by LCH. Lead program participant is required to pay a one-time start-up fee to LCH via check or credit card before qualified leads will be distributed. Company representative signing below acknowledges that contractor company shall be responsible for any and all leads given to program participant. In the event that a lead given to program participant contains invalid information and homeowner cannot be reached at this number, day or night, LCH will issue internal credit and replace the lead, so long as LCH is notified of such error within five days of contractor receiving the lead. Contractor company authorizes LCH to charge contractor company account listed above the amount of \$49.95 one-time as a startup fee. Thereafter, LCH will have authorization to charge contractor company account listed above an amount of \$30.00 per lead, up to the stated maximum limit set above by contractor company. Any charges not accepted by credit card company will be due and payable by contracting company within three business days with a late fee of \$30.00. If account is referred to collection, contracting company agrees to pay all collection related costs.

Once account is set up, contractor is responsible for going to their online account to set categories of work and work area. LCH will not issue an "out of area" credit for any contractor after November 1, 2006.

Program lead participant agrees that LCH shall bear no responsibility for work done by contractor for homeowner(s) or the resulting payment or lack of payment to contractor by homeowner(s) for which contractor does work. Contractors are acting as independent workers and are not deemed to be employees of LCH nor shall any contractor have any right to act on behalf of LCH beyond that expressly granted herein. Approved lead participant contractor agrees to maintain the proper licensing, insurances, and bonding as required by the State of California for every project performed. Contractor shall notify LCH immediately if any of these items change. Approved Lead Participant agrees to defend, indemnify and hold the League of California Homeowners, its ownership, board members and employees harmless from and against any demands, claims, charges, or liability of any kind arising out of any work performed by Approved Lead Participant, including, without limitation, claims by any customer, subcontractor or supplier of contracting company.
